## **Code of Compliance:**

# Renters/Invitees:

Any person staying overnight at your site who is not immediate family of the occupier should be paying the fees as set out in "RBHP Licence To Occupy item 1.35 (a) For each adult (including person 16 yrs & older) \$10 per night (b) each child under 16 yrs \$5 per night paid to the Camp Manager.

#### Insurance:

All sites must have full cover insurance.

#### **Caravans:**

All on site caravans must have and display a current electrical warrant – Ross Cook holds an updated register please enquire with Ross if your current warrant has expired – rosscooknz@hotmail.com

#### **Installations:**

Should you be considering upgrading your current hot water system or cooking appliance (stove) then your only option is GAS. No electrics. NB: The maximum permitted gas storage on your site for hot water, barbecues, patio heaters etc is 100kg (otherwise a permit is required)

# **Managers House:**

The outside upgrade is now complete with a very pleasing result achieved.

# **Arrival/Departure**:

Remember to sign in, sign out. The book is in the entrance way into the Managers house. Most do - Some don't.

In an emergency this information is of vital importance.
